Election Guidelines:

Chief Election Officer- Dr. Dega Narayana Reddy

- 1. Elections will be held once in 3 years.
- 2. The term of office bearers will be 3 years.
- 3. Members who have been with CSEPI for atleast 3 years are eligible to contest for election.
- 4. The members should had attended at least two AGMs in the previous 3 years to be eligible to contest for the board (President, Vice President, Hon. Secretary, Ho. Joint Secretary, Hon. Treasurer)
- 5. After 3 year of Membership, one is eligible to contest for the post of committee member.
- 6. Only those members who had been in the executive committee for atleast one term, are eligible to contest for the posts of Hon. Joint Secretary.
- 7. Only members who had been in the executive committee for atleast two terms are eligible to contest for the posts of Hon. Secretary.
- 8. The member who held the post of Hon. Secretary for atleast one term will eligible to contest for the post of Vice President.
- 9. The members who held the post of Vice President, or Hon. Secretary for one term will be eligible to contest for the post of President.
- 10. No office bearer/ Committee member (Regional Coordinator) can hold the same post for more than two consecutive terms unless co-opted. However they are eligible to contest for elections after a break of atleast one term.
- 11. In the event of no nominations for a particular post, the executive committee will coopt an experienced (Those who have already held the post previously member for the same).
- 12. Candidates for the election should be physically present at the election AGM.
